Dear Mr. Kortner, -

thank you very much for your letter of May 28th which I found yesterday upon my return from Italy. But yes, I remember very well having met you; moreover, I am quite aware of your recent successes in television. So, no "introduction" would have been necessary.

As for THE MAGIC MOUNTAIN, we have just sold the movie rights to Wolfgang Reinhardt whom, I am sure, you know. Unless I am sadly mistaken, however, the television rights are not included in our contract with Reinhardt; nor do I think that said contract contains any clause forbidding us to sell the television rights whenever we please, no matter whether the film has already been done or not.

There were still some minor alterations that we wish Reinhardt to make in the contract which is why I may sound a bit vague regarding the exact terms of the document in question. Of course, you might simply get in touch with Mr. Wolfgang Reinhardt (Widenmeyerstrasse 36, München, telephone 29 50 07). On the other hand, it might be better if we had a talk on the subject before you approach Reinhardt. In all probability, I shall be here until June 20th and subsequently from June 25th till July 1st.
