SUBJECT : ORDERS

1. You will proceed immediately into 21 Army Group area for a three-day facility in BRUSSELS and ANTWERP, arranged by P. & P.W. 21 Army Group (reference PPW/832, 25 Oct 44) commencing 27 October.
2. You will travel in your own car directly to BRUSSELS, reporting in to ADPR #3 P.R. Group First Canadian Army, Rue Baloise Bldg., Rue Royale. No facilities will be provided beyond those which #3 P.R. Group is normally prepared to offer. You are warned that no contact with military organizations other than hospitals or other installations where women are employed may be made.
3. You will present a copy of these Orders to #3 P.R. Group on reporting in.
4. You will report back to Major Andrews P.R.D. Facilities Officer, American Express Bldg., PARIS, immediately on your return.
