PLEASE TAKE NOTICE THAT PURSUANT to your request for a review of the rejection by the Commissioner of Taxation and Finance of your claim for the New York State Veterans Bonus an Informal Hearing has been authorized by the Commissioner and will be held on the following day, date, time and place:

You are hereby requested to appear and bring any witnesses or evidence available to you that may have a bearing on this determination.

In presenting your case, you may be represented by an agent or attorney, if you so desire. The Bonus Law does not permit an agent or attorney to receive compensation for his services in prosecuting your claim for any bonus payment.

A postponement of this Hearing will not be granted unless a valid reason is presented. Application for postponement must be made in writing and received by the VETERANS BONUS BUREAU, 1875 NORTH BROADWAY, ALBANY 4, N. Y., at least five (5) days before the date of the Hearing.

Failure to appear, or tardiness in appearing at the time and place of a Scheduled Hearing will be deemed a withdrawal of your request for a Hearing.
